*The mail must not exceed **10 MB** since the system would automatically reject it. It is advisable to use PDF format files and when sending to tick the "Request a delivery receipt" box to ensure receipt by GTT.*

• SEND DOCUMENTS WITHIN 10 DAYS

As envisaged by resolution n° 2010 06124/119 dated 19 October 2010, the communication of passage in the Limited Traffic Zone must be forwarded to G.T.T. within 10 days- ten -(from the first day of transit included, **contemplating Saturday and public holidays**).

• FORM ALWAYS UPDATED

To request the exemption, the form must be updated, so we invite you to download the forms from the G.T.T. website or City of Turin website **always concomitantly with the request.**

If the request is not filled out in full and does not have the supporting documentation: IT WILL NOT BE CONSIDERED.
